SUMMARY:

Under the supervision of the RN, the Licensed Practical Nurse (LPN) carries out a comprehensive chemical dependency assessment at intake, manages residents consistent with the program triage plan and provides a variety of nursing services to residents. Must be able to support a trauma informed care environment.

DUTIES AND RESPONSIBILITIES:

A. Assessment and Triage

- 1) Follows medical protocol for determining resident's medical needs.
- Consults with appropriate nursing staff and/or Medical Director regarding medical problems or possible need for transfer to other levels of care.

B. Nursing Care

- 1) Monitors vital signs and other signs and symptoms of withdrawal or medical complications.
- 2) Completes initial and comprehensive medical treatment plans as required.
- 3) Updates treatment plans as needed.
- 4) Assures that all medications are safely stored, inventoried and distributed per MD direction and program policy.
- 5) Provides emergency and follow-up medical care as needed.
- 6) Provides supportive and motivational counseling to residents.

- 7) Conducts or assists in providing structured group activities and discussion groups for the residents.
- 8) Assists in the management of resident behaviors.

C. Other Duties

- 1) Provides transportation and may accompany residents to hospitals and/or other appropriate providers to meet service needs.
- 2) Maintains accurate and timely medical records consistent with program policies and standard nursing practice.
- 3) Maintains administrative and statistical records as needed.
- 4) Participates in staff meetings, case conferences and in-service trainings.
- 5) Completes other related tasks as necessary.
- 6) May assist in the orientation of new staff.
